#### 1. What is provided in this Privacy Notice?

# 4. Processing of personal data of children

- 4.1. Only persons over 14 years of age can become registered users, participate in the loyalty programme and express consent to direct marketing. Individual loyalty programs or contest conditions may provide for a different, higher minimum age limit for participants.
- 4.2. If we have reasonable grounds to suspect that we are processing data from individuals under the age of this section, we will remove the data from those databases.

## 5. What information you must provide us and why?

Please review the answer to item 3 above - you must provide the information about you that is necessary to:

- 5.1. enter into contracts with you and fulfill contractual obligations;
- 5.2. enter into contracts with the persons you represent and fulfill contractual obligations;
- 5.3. give you access to wireless internet on our trains.

If you do not provide the specified information, we will not be able to enter into contracts with you and / or the persons you represent and fulfill contractual obligations.

## 6. Where do we get information about you?

Most of the information is provided by you, but we can get some of the information from:

- 6.1. the legal entities that you represent or where you are employed at;
- 6.2. joint-stock company "Lithuanian Railways" (for the purposes specified in items 3.5, 3.14, 3.15).

## 7. Who do we pass on information about you to?

We will only transfer or share information about you to/with our partners, service providers, and the following entities to the extent necessary and permitted by applicable law, including for the reasons listed in Item 3:

- 7.1. parent company of UAB LTG Link, i.e. AB Lithuanian Railways, and its subsidiaries (data may be transferred for all purposes specified in item 3);
- 7.2. banks performing settlement operations (data shall be transferred for the purpose specified in Clause 3.1);
- 7.3. courts, supervisory, law enforcement and other public authorities (data may be transferred for all purposes listed in the answer to question 3);
- 7.4. lawyers, notaries, bailiffs, auditors, consultants, IT maintenance service providers, electronic communications service providers, insurance companies, companies providing archiving services and other services to the Company (data may be transferred for all purposes provided in the answer to question 3).

Please note that the Company selects as data processors only those persons who have provided the Company with a sufficient guarantee that they apply appropriate technical and organizational measures to ensure the safe processing of personal data and the appropriate level of data protection in accordance with applicable legislation of the European Union.

## 8. Will your data be transferred outside the European Economic Area?<sup>2</sup>

In most cases, personal data are processed and transferred within the European Union and the European Economic Area, but where necessary for the provision of certain services, data may be transferred and processed outside those territories, provided that an adequate level of protection of personal data is observed. Where permitted by law and for the reasons set out in Section 7 of this Privacy Notice, we disclose information about you:

- 8.1. on the basis of the European Commission's decision on adequacy, meaning that the European Commission has recognized the country in which the third party is established and / or operates as ensuring an adequate level of protection of personal data;
- 8.2. we have signed a contract with a third party based on the Standard Contract Terms approved by the European Commission;
- 8.3. we have received the permission of the State Data Protection Inspectorate;
- 8.4. by using, where possible, other possible personal data protection measures and allowable derogations.

#### 9. What rights do you have?

The GDPR and other regulatory enactments give you rights, provide for cases when you can exercise them, the procedures you must follow, as well as the exceptions when you may not exercise those rights. When permitted by law, you may:

- 9.1. access your personal data, i.e. receive a notification confirming whether LTG Link processes your personal data and, if so, request access to the processed data and related information;
- 9.2. provide us with a request to correct inaccurate, incorrectly used information or to supplement it when it is incomplete;
- 9.3. provide us with a request to delete information we hold about you if we use it illegally;
- 9.4. provide us with a request to restrict the processing of available information about you when you dispute the accuracy of the data or object to the processing of the data, do not consent to the deletion of your illegally processed data, or you need the data to claim, enforce or defend legal claims;
- 9.5. to object to the use of data when we process your data in the legitimate interests of LTG Link and / or third parties;
- 9.6. provide us with a request to transfer (receive) data which you have provided to us under a contract or consent to the processing of data and which we process by automated means in a shared electronic form;
- 9.7. object to being subject to a fully automated decision, including profiling, if such a decision is likely to have legal consequences or similar significant effects on you;
- 9.8. revoke the consents given to us regarding the use of your information when we use the data on the basis of your consent;
- 9.9. lodge a complaint with the supervisory authority, in particular in the Member State where you are domiciled or where the suspected violation of the GDPR has been committed, and apply for legal remedies. The supervisory authority in the Republic of Lithuania is the State Data Protection Inspectorate (L. Sapiegos st. 17, Vilnius; email: ada@ada.lt), but first we recommend that you contact us and we will try to resolve all your requests together with you.

## 10. How can you exercise your rights?

To exercise your rights under Item 9 of this Privacy Notice, you must:

- 10.1. personally deliver the application for the exercise of the data subject's rights (hereinafter the **Application**) <sup>3</sup> to the Company's headquarters, Passenger Information Centre or to the Data Protection Officer at the addresses specified in Item 14 of this Privacy Notice (the Application must be accompanied by an identity document);
- 10.2. send the Application to the Company or the Data Protection Officer at the postal addresses specified in Item 14 of this Privacy Notice (a copy of the identity document certified by a notary or in other procedure established by regulatory enactments must be attached to the Application);
- 10.3. submit the Request to the Company or the Data Protection Officer at the email addresses specified in Item 14 of this Privacy Notice (the request submitted by email must be signed with a secure electronic signature).

## 11. Do you profile me and make automated decisions?

The company may profile you for statistical purposes. Also, in order to prevent the sending of unsolicited marketing offers, we classify you according to the date of conclusion of the contract, the term of the contract, the status of the contract, your age.

#### 12. Does your website leave cookies on my computer or device?

#### 13. How can you manage cookies?

By visiting the website (www.ltglink.lt) you can choose whether you want to use cookies. You can manage cookies on the website itself and (or) delete them according to your browser preferences. You can opt out of the use of optional cookies on the website, but the website may be not fully functional, for example, you will not be able to use the chat window assistance when purchasing.

You can choose which cookies you would like to accept and which you would like to reject in your browser settings. You can delete all cookies already on your computer, and in most browsers you can prevent cookies from being saved. The location of these settings depends on the browser you are using.

If you do not agree to the storage of cookies on your computer or other device, you can revoke your consent at any time by changing the settings on the website and deleting the stored cookies in your browser. If you choose to delete cookies, keep in mind that all your options will be removed as well. In addition, many websites (including www.ltglink.lt) may not function properly if cookies are completely blocked. For these reasons, we do not recommend disabling compulsory cookies.

## How do I delete cookies from my device?
